#### GENERAL INFORMATION

OARS, Corrective Approach Pellet, is an excellent tool for combatting water repellent soils or localized dry spots. OARS Pellets can be applied with the AQUA-AID PROportioner system or similar applicator during hand watering and/or syringing. Apply throughout the year with no phytotoxicity to all types of turf grasses. annuals, and perennials.

One OARS Pellet will cover 1 to 3 average size greens, up to 15,000 ft<sup>2</sup> (1,393 m<sup>2</sup>). Apply OARS Pellets as needed.

OARS Pellets will dissolve within one hour at water pressures of 90 to 120 psi (620 to 827 kPa). The rate at which an individual OARS Pellet dissolves is determined by water quality, temperature, pressure and flow rates. The flow of water through the PROportioner should follow the molded arrow. Please note some applicators have the flow opposite the molded arrow.

#### DIRECTIONS FOR USE

Greens, Tees, Fairways, Lawns and Sports Turf

Insert one OARS Pellet, with or without container, into the PROportioner jar and use when hand watering and/or syringing. Apply to water repellent soils, localized dry spots or hard-to-wet areas as needed throughout the growing season.
